

RMDC Financial Policy

Applicability

These Terms of Use and Sale apply to all websites owned, operated, and maintained by or for the **Real Men Discipleship Conference (RMDC)** and upon which these Terms of Use and Sale are linked. Delivery of Goods (Tickets)

Tickets will be delivered digitally to the email address provided during the purchase process. It is your responsibility to ensure that you have provided accurate contact information. If you do not receive your ticket, please contact us.

Price and Payment

The price payable for your order is as set out at the time you submit your order. The price includes taxes at the current prevailing rate. Any additional handling or processing charges will be displayed before payment is required.

Password and Account Security

You may create your own account on the RMDC Site by completing the registration process. You are responsible for maintaining the confidentiality of your password and account details and for any activities that occur under your account.
